I'm afraid your advice is incorrect. As I thought, the advice from the Committee Clerk is as follows:

"No member of Development Control subcommittee should have any contact with a person, or body of people, who have an interest in a planning application. If the member is contacted, he or she should write to the interested party and advise them of this rule. The member can then direct the party to a fellow ward member who is not a member of Development Control.

In the case of Kings Cross Railway Lands Group, they may meet with councillors who are not members of DC, and any written submissions on planning applications should be made to the committee clerk e.g. Elizabeth Dowuona in Committee Services."

Dear Cllr Blackwell,

Una Sapietis (King's Cross Railway Lands Group) has asked me to follow up your kind offer to help arrange a meeting with cllrs on the King's Cross development.

The format we envisage is a Briefing session, in which community members provide short presentations on the Argent plan, including information about the Mayor of London's response and the Network Rail application. This would then be followed by discussion.

We would like the meeting to take place during week commencing 20th February and seek your guidance as to the most appropriate day and time. We hope it would be possible to book a committee room at the Town Hall.

In terms of which cllrs to invite, we were thinking of the cllrs on development control sub-committee, and local cllrs from the Kings Cross and St Pancras and Somers Town wards. We would like yourself to be present, and out of courtesy to also invite the Leader and other Deputy Leader.

Given the joint nature of the planning application we see some benefit in inviting a few cllrs from Islington (West Area) though we appreciate the sensitivities and would like your advice on this.
